

# Visitor Biosecurity and Health Questionnaire Part 1

## Poultry Research Facility (PRF) Biosecurity Policies:

### Form must be filled out and sent to PRF Manager or designate BEFORE visit to assess entry eligibility (24 hours pre-visit)

#### 1. With respect to attire and cell phones:

- All visitors must wear PRF-provided clothing, boots, gloves, N-95 mask or a surgical mask while in the facility.
- Visitors and students in PRF for labs will not bring cameras or cell phones with them.
- Regular staff, technicians, and graduate students who require a cell phone while in the facility for general communication, safety, or working alone procedures, may take their phone in provided it is cleaned with a disinfectant wipe on entry and on exit. Alternatively, the cell phone may be placed in a disposable, clear plastic bag.
- Photos and/or video, under specific circumstances, may be approved. Please discuss what you need with the PRF manager or delegate, and/or the Director of Animal Care.
- **No** photos or video, even if approved by PRF senior staff or the Director of Animal Care, should be posted on personal social media pages under any circumstances.

#### 2. With respect to visits on other farms or contact with other animals **within Canada**:

- No entry to individuals who have had any contact with poultry in Canada in past 72 hours (3 days).
- No entry to individuals who are wearing clothing or footwear that has been on a farm or had contact with poultry or other animals, including pet birds.
- No entry to individuals who arrive in vehicles that have been on other poultry farms or have been in contact with poultry (unless the vehicle has been cleaned inside and washed outside).

#### 3. With respect to travel **outside of Canada**:

- No entry to individuals who have had any contact with poultry outside of Canada in past 72 hours (3 days).
- Your entry will be restricted and individually assessed for risk if:
  - You've been outside of Canada (INCLUDING USA) in the past 5 days.
  - You've been on a farm or had contact with livestock outside of Canada (INCLUDING USA) in the past 7 days.
  - You've been to a country 'NOT recognized as free from Foot and Mouth Disease' by the CFIA in the past 14 days.

#### 4. With respect to human health:

- No entry to individuals who are actively showing acute symptoms of a 'flu-like' illness, including sore throat, coughing, fever, chills, headache, muscle pain, extreme tiredness.
- Any person with a compromised immune system, or living with someone with a compromised immune system, due to health or medication, is advised to contact their medical doctor **prior** to their visit to the PRF.

#### 5. With respect to the biosecurity and health questionnaire (see following page):

- Your responses to the questions will be used to screen for potential biosecurity threats to the flock at PRF, as well as identify potential risks to your comfort or health that could result from visiting the facility. You will be asked to sign this document to confirm all information you provide is correct. All personal information collected will remain confidential and will only be used to evaluate any biosecurity risk to PRF birds, or to evaluate any health risk to the visitor.
- All visitors must sign the visitor book (in addition to filling out this questionnaire).
- **Keep in mind the answers to these questions and if anything changes prior to your visit let the host know so admittance can be reassessed.**
